7. **President's Report Bob Penny**

A sincere thank you for attending this year's AGM. As the evening unfolds, you'll discover what a full season this club has experienced. We have had our ups and downs with several sad situations, and we face challenges for the future. I'm pleased to say, confidently, that with the team of committee members we have on board and with their experience, commitment and enthusiasm we can look at positive opportunities as well as firming up the foundations of the club.

You will all be aware that The Stute and the Holwell Sports and Social Club has gone into Administration due to financial issues and debts associated with The Stute. Administrators have been appointed and their role is to liquidate Holwell Sports and Social Club's assets so that funds can be created to settle the outstanding debts. I make it clear that Holwell Sports BC is not in debt to anyone but by association with the Holwell Sports and Social Club the Administrators sale of assets could affect this club. To be proactive the key partners of the site i.e. the Holwell Sports Bowls Club and Holwell Sports FC have created a forum called the Holwell Sports Union to work together to establish a united and consistent voice for discussions with the Administrators. We are also working closely with Holwell Sports FC to enable them to meet their FA and league obligations for post-match refreshments.

At the time of preparing this report, one meeting has been held with the Administrators and representatives of HSBC and HSFC. The meeting has been productive and constructive. The Administrators are to be in discussion with TATA as that company has an interest by way of an existing covenant to the future use and the financial aspects of the land which was bought from them some years ago. There are various options open to us, some of which are favourable and others which are not. We've made it clear to the Administrator that our aim is to stay on our site and seek to take direct ownership of the Bowls Club land.

My particular thanks go to Peter Karran and Ruth Cross for their guidance and expertise and the production of helpful correspondence to the Administrator. We all had opinions about the viability of the Stute and had

heard rumours about its possible closure last spring. The Holwell Sports Union panel has stood up to the plate and offered to assist in this unforeseen scenario.

It is anticipated that the process will not be quick, and we are proceeding to ensure we are in the best place to respond to opportunities and challenges that may arise. It is also anticipated that there will be decisions required by the membership of this Club and these will be dealt with in accordance with the Club's Constitution. We'll keep you posted on progress through Sue's updates. Further information and any questions may follow the Secretary's Report.

And now on to what the bowls club is here for..... the enjoyment and participation in the sport of bowls. I'd like to start my report at the start of my term of office when I set out my hopes for the season. I felt that winning the double of the Kings Cup and the Melton Triples league was within our capability, and I'm delighted to say that with the leadership of Pete Orridge and a selection of players those hopes have been realised and we have won the double this season.

Our midweek medley and ladies and friendly fixtures have been well led by Janet and Fred and I thank them for their efforts and achievements. Arthur and Ann have selected teams for a number of weekend friendly games, and I thank all players who have put their names forward. Friendly games remain the lifeblood of the sport and is a perfect way for our members of all abilities to enjoy and develop their skills in a friendly environment without the pressure of competitiveness.

I'd like to thank Vice President Sue for standing in for me when I've been away on umpiring commitments. Sue has done a great job as Vice President and selecting her tour venue.

The Club Captains will give their reports, so I won't go into any further detail other than to convey my thanks and appreciation for their work and great achievements.

In early August we enjoyed a summer Saturday afternoon to get together for Presidents Day. Unlike last season we had good weather and were able to play a full 6 triples representing the Presidents team against 6 triples representing Vice President Sue. It was a fun afternoon with an Australian theme. We started by playing a spider competition in aid of Visually Impaired Bowlers Association and raised £58.60 from players' entry fees. Well done to Geoff for winning the bottle of whisky that was generously donated by Alan Tipper.

The animal themed teams representing the President played 3 games of 6 ends against the city themed teams. Presidents Day was a very close event with 2 teams on equal wins, equal points and equal shot difference at the end of the event. President's Day was completed by a fantastic "bring and share" buffet. A huge thank you to everyone who participated and brought such a range and quantity of items for the buffet.

Our Scenery and seaside tour to Essex and Suffolk in September was a great success on a number of levels.

- We had a group of 43 tourists, and we attracted several new tourists from this and other clubs. The group was a great combination with many memorable moments
- We made new friends at the host clubs of Braintree, Col West End, Felixstowe and Frinton.
- We played 4 games and won 3. Our 1 loss was to Fexistowe and Suffolk BC (this year's National winners of the Tony Alcock Trophy!)
- We played on excellent greens and experienced wonderful hospitality
- We raised £169 for Air Ambulance and £185 for RNLi 200 anniversary
- The Holwell tour account is in a healthier position than when it was resuscitated.

Please give your support to incoming President Sue and the September 2025 tour to Scarborough which is going to be equally enjoyable and rewarding.

The officers of your committee and many unsung volunteers put a great deal of effort into the club without getting the recognition they deserve. They're prepared to put in the graft without reward. Jobs such as the equipment store flooring and redecoration, the repainting and repair of the entire perimeter fence and the refurbishment of the Holwell BC sign and canopy, property repairs and improvements wasn't done by overnight fairies. It was done by club members.... Thank you all.

We've also had a selection of social events which have been very enjoyable and well supported. Thanks to those such as Tom and Janet who make the effort to provide these events. Thank you also to those who support these events to ensure they are a social and financial success.

I have had a great time in my role of President. It's been a privilege to work with your committee and it's an eye opener to the amount of work that goes on behind the scenes. I have had some clashes with my commitments in my umpiring roles, but I've tried my best. I may have done some things differently but sometimes change opens new ideas and opportunities.

8. **Secretary's Report** Sue Lemon.

Sadly, we have lost members who did so much for the club, and all will be sorely missed on and off the green. David Reek one of our longest serving members who had been in ill health for some time. David's input over many years was invaluable and contributed to the club we have now. Phil Hardy a Pebble Boy and Monday Club member who enjoyed so much playing and taking part in club events over the years. Vince Darling whose death came as such a shock to everyone. Vince was always there to offer a helping hand on match days and on the green. It is sad he did not live to get the County Badge he was so proud of achieving. Margaret and Clifford Thompson who died within weeks of one another. Margaret whose baking and contributions to Bring and Shares was legendary along with providing teas for the Monday Chummy and friendly matches for many years. Clifford whose handy work is everywhere in the club and was always provided willingly and happily. Clifford was responsible for U3A using our green which resulted in the club gaining members when we so badly needed them. He also made and donated our Australian Pairs Trophy.

The County has introduced an online system named MATCH on which clubs register their players and entries for County Competitions. This year the club handled making the entries for the players entering competitions which took some time. With the introduction of the system came a change to the payment of Affiliation Fees to both the County and Bowls England. These are now calculated by the system and must be paid by the 1st of March. It is for this reason the committee have put forward the first of two propositions to be voted on and are shown on your agenda. It is also the reason we need to change our membership year to allow us to have correct membership details for the coming season as we must pay out £13 per member by the first of March.

First Proposition: Amendment to Constitution

3.3 Membership Subscription Fee

3.3.1 The rate of Subscription Fee for each category of Membership shall be proposed by the Committee to the members at the Annual General Meeting in each year. Any proposed changes shall be approved by a majority of those present and entitled to vote and shall become operative from 1st March each year. The current rate of Subscription Fee shall be prominently displayed in the Club premises.

3.3.2 All members shall pay their first annual subscription fee as shall be requested upon election to the Club and thereafter annually by 31st March.

Amendments proposed:

Item 3.3.1 - 1st of March each year to be amended to read the 1st of February each year

Item 3.3.2 - 31st March to be amended to read 31st of January

We currently have in place a penalty for paying the membership fee after the due date, this is £5, and the committee are seeking your approval to put this in place when the changes are made.

The Second Proposition: Members will not need to pay Stute fees next year to be a member of the Bowls club.

The Committee is therefore proposing that we increase membership fees for 2025 by £10 to £60. This will likely raise around £600 and help us combat inflation and maintain our contingency fund.

The committee hope that you will support these propositions put forward to support the MATCH system and to safeguard our club's finances.

The generosity of our members to the club cannot be overvalued. One member has donated four pushers to the club to supplement those we had. Our President Bob has digitalised the information on our Honour Boards, and it is now available on our website as a series of PDFs. Members have provided food for our Bring and Shares, organised social events and ensured that catering is covered for the County Matches and Finals we have hosted. Margaret Thorpe has organised the catering for the Saturday Friendly along with the ladies who have volunteered for Tea Rota. This along with the voluntary work provided so willingly by the members of the committee ensures our club thrives.

President Bob has provided a summary of the activities which have been taking place since the Stute went into voluntary liquidation. At the meeting held on the 16th of July Ruth Cross and Peter Karran stepped forward to help the committee along with Pip Allnatt the Leader of the Council. Their

involvement has been invaluable for us to prepare ourselves for the negotiations with the Administrator and we are very grateful.

The club has applied for and been granted a Premises License to sell alcohol because of the liquidation. We will have to ensure the club meets the requirement for Fire and Public Safety as a result and the committee will be addressing these in the coming months. We have also got an agreement in place for the Football Club to use our clubroom after first team games to provide hot refreshments, (which they order in) as stipulated by the FA. We are also being considered as a venue as a Polling Station at the time of elections. The Stute provided these facilities in the past.

My thanks go to President Bob, the committee and members for your continued support. President Bob has done an excellent job, and I look forward to working with President Sue when she takes up office, I hope she enjoys her year working with us all.

9. The Treasurers Report:

At the 2023 AGM I reported that Club funds were £7,857. As of 17th September 2024, total funds stand at £6,724. I expect us to finish the year between somewhere above £7,000.

Year to date expenditure is £9810. This is higher than last year by about £1,000 once ad hoc capital expenditure is removed, which this year included of a new Sprayer (£881) and a second-hand mower (£500).

The increased spend was largely the result of the Bar License application which cost £765 and general inflation. As usual maintaining the green and clubhouse formed the major spend. Water usage was lower this year because of all the rain. Thank you to everyone who helped to keep electricity usage down to 65% of last year (£675 vs £1024).

Year to date income is £8677. With Presentation night still to come I expect year end income to be slightly down but in line with last year. The County games we hosted were once again very lucrative. Members will not need to pay Stute fees next year in order to be a member of the Bowls club. The Committee is therefore proposing that we increase membership fees for 2025 by £10 to £60. This will likely raise around £600 and help us combat inflation and maintain our contingency fund.
